1. The Naumule Rural Municipality invites Bids from registered bidders/contractors for the construction of following projects.

Bid document must be valid for a period of 90 days after opening of bid document and must be accompanied by a scanned copy of the bid security (pdf format) amounting to a minimum as specified below in table, Which shall be valid for a period of 30 days beyond the validity period of the bid in Dharaudi A/C No.10409100717124000003 of NMB Bank, Naumule Branch, Dailekh or Bid bond in the form of bank guarantee issued by the bank recognized by GON as a "A" class commercial bank, which shall be valid for 30 days beyond the validity period of the bid.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at the below mentioned date and time at the office of the Naumule Rural Municipality, Naumule-Dailekh.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The format of the bid security (Bank Guarantee) should be in accordance with form of bid security included in bid documents.
10. Others conditions will be applied according to Procurement Act, 2063 and Procurement Regulation 2064 and other relevant law of government of Nepal.
