

1. The Naumule Rural Municipality invites Bids from register bidders/contractors for the construction of following projects.
2. The Estimated amount (excluding VAT and Contingencies) for the works is mentioned in the below table.

Bidding documents may be purchased separately for each Bid from the office of Naumule Rural Municipality, Naumule-Dailekh by eligible Bidders on the submission of a written application, along with the copy of up to date company/firm registration certificate, VAT and PAN registration certificate, Tax clearance certificate of F/Y: 2076/077 and upon payment of a non-refundable fee of Rs. 3000.00 till date 2077/09/10 B.S. during office hours. Bid document must be valid for a period of 90 days after opening of bid document and must be accompanied by a bid security amounting to a minimum of specified as below in the form of cash voucher deposited in Dharauti A/C No.10409100717124000003 of NMB Bank, Naumule Branch, Dailekh or Bid bond in the form of bank guarantee issued by the bank recognized by GON as a "A" class commercial bank, which shall be valid for 30 days beyond the validity period of the bid.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on below mentioned corresponding date 2077/09/11 B.S. at the office of Naumule Rural Municipality, Naumule-Dailekh.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The format of the bid security (Bank Guarantee) should be in accordance with form of bid security included in bid documents
